- STAFF REPORT Justine Nevarez, Community Outreach & Events Manager
 - a. DTLB Art + Design Walk Recap
 - Nevarez provided an overview of the largest Art and Design Walk to date, featuring over 40 locations. Despite challenges with coordination and artist participation, it was a successful event, sponsored by Long Beach Transit.
 - A Long Beach Transit bus wrapped with the new "Opposite of Ordinary" design was used for free transportation.
 - The Committee discussed the importance of condensing the event for a more concentrated and efficiently managed experience.
 - b. DTLB Pre-Holiday Bar Crawl Preview
 - The DTLB pre-holiday bar crawl will take place on November 21. Nevarez shared details about participating bars and the event's structure, noting the involvement of the Downtown Residential Council (DRC) as a partner.
 - c. Microgrant Report
 - The Friday Night FAHM event featured Filipino food, crafts, DJs, and a Makers Market, and it attracted a strong turnout.
 - The LB Vintage event included a live mural painting by LaJon Miller and pop-up shops, with positive feedback from participants.
 - Upcoming micro grant events include a children's orchestra class, the Winter in Wilmore holiday market, and the launch of the Visit Long Beach safe spaces directory.
