 - b. Update on Events Calendar
 - Nevarez shared the events from March-December: Celebrate Downtown, Taste of Downtown, Juneteenth, Buskerfest/Pow Wow/KCRW, Unfiltered, Shop Small Saturday, and New Year's Eve. She added that DLBA will be working with an event producer for Taste of Downtown.
 - c. Update on Celebrate Downtown
 - Nevarez informed that the new Lincoln Park is the location for Celebrate Downtown on Thursday, March 24, 2022.
 - Coward advised that this event gives opportunity to showcase the PBID
 process, businesses in Downtown, and that a discussion can take place on
