# PUBLIC SAFETY COMMITTEE MEETING

 Call to Order, Welcome and Self-Introductions – Denise Carter, Chair <u>Meeting presentation</u>. Meeting called to order at 4:30 PM.

2. ACTION: Approve minutes from June 25, 2021 Meeting

MOTION: 1st: Welch, 2nd: Gibbons

**<u>VOTE</u>**: None opposed. No abstentions. Motion passes.

- 3. Discussion of the Management and Enforcement of Scooters on Sidewalks in Downtown
  - Nueno presented an update on the Micromobility Program specifically on e-scooters. The permit program launched in August 2020. The program allows for a max of four e-scooter permits (Lime, Razor, Bird and VeoRide). Each permit is for one year and the permit fee is \$25k with an additional fee of \$100 per device/vehicle.
  - To monitor activity for the scooters, the City of Long Beach uses a data aggregation software. This software collects vehicle trip counts, geofencing rules, fleet size management, popular routes, heatmap, daily dashboard, real time GPS data and policies and rules for operators.
  - Average trip length for January June 2021 was 1.3 miles, with a total of 454,734 miles and total trips of 398,244.
  - There are currently 500 scooters per operator (2,000 total) and the plan is to increase up to 1,000 scooters per operator making it a total of 4,000 scooters total.
  - Nueno informed the committee that the e-scooter program is a great program for the city and the City of Long Beach plans to improve it and increase awareness of what is allowed and not allowed to make sure safety is top priority.
  - Sgt. Ernest stated the scooters have been problematic in the downtown area and informed the group that officers are passing out flyers with rules and laws to all riders. The police department also plans to post this information on their social media platforms to spread awareness.
  - Gibbons expressed how the scooters are parked in places where they shouldn't be like in front of her driveway and asked who she can contact.



- Nueno provided Gibbons with her contact info to notify the vendors and explained that the vendors are required to fix it within 2 hours.
- Nueno explained geofencing and how it works. Geofencing allows the city to regulate where people may be permitted to ride and set rules for e-scooters.
- Krieger expressed that e-scooters are an ADA violation because they are in the way on the sidewalk.
- Welch asked if riding on Ocean Blvd is allowed. Cruz explained, e-scooters are not allowed on streets posted over 25 mph. Since Ocean Blvd is posted at 30 mph, e-scooters are not permitted as it is dangerous for riders. Due to inaccuracies of geofencing, this street and others are difficult to regulate. The GPS drift is up to 30-40 feet so that's practically the width of the rode.
- Coward announced a partnership with LBPD South Division, similar to their efforts in 2019, to pass out educational materials to riders leading up to a period of enforcement by officers.

  - Sgt. Ernest mentioned City Council approved additional funding for the police department. The additional funding is going towards putting extra police officers out in the streets over the weekends and nights.
  - Ernest touched on the recent shooting. Friday night and early Saturday morning, there was an altercation with a group of people that quickly turned into a shooting. The person who pulled out a handgun was quickly identified the next day. The suspect is now in custody and there is an ongoing investigation.

- Be Cotte introduced Caesar Garay who is a new operations assistant manager under Block by Block's employment.
- Be Cotte presented the employee winners for the quarter. Lilia Fuentes who

  information center.
- Coward added DLBA is working on incentives and pay rate for our clean and safe team.
