 - a. FY22-23 Public Safety Committee Working Group Projects
 - i. Fresh Start Donation Program
 - The program was extended for 2 more weeks with a July 10th pickup.
 - ii. Safety Walk Audits
 - The first volunteer-based Safety Walk Audit took place after the Coffee, Conversation, & Clean Up event on Saturday June 17th.
 - The next audit following CCC will be on Saturday July 15th.
 - Garay advised that the City is working on repairs to the tree well cover in front of Johnny Rockets.

 - Torres is working on consolidating the document and integrating what DLBA's role is.

 - Ahumada advised that the Park Ambassadors Program started with 8 staff who will be enforcing the new ordinance to playground areas.
