 TREASURER'S REPORT- Jeremy Ancalade, DLBA Vice President of Finance & Administration & Mike Gold, Treasurer Draft Year-to-Date Financials through September 2023

- Gold & Ancalade reported on the financials for the entire 2022-23 fiscal year. These
 are unaudited numbers.
- Expenses that were overbudget were offset by deferred revenue. Overall, the organization is breaking even with expenses vs. revenue.
- Cadavona asked if DLBA has considered developing a process for reserve/emergency funding. Ancalade noted that nothing exists yet, but perhaps the Finance Committee can create something.

5. PRESIDENT & CEO REPORT – Austin Metoyer

- A. Downtown Public Safety Discussion
 - Metoyer updated the Committee on public safety concerns throughout Downtown that have arisen
 in recent weeks. DLBA is coordinating with the City, Long Beach Police Department (LBPD),
 Mayor's office, and Convention and Visitors Bureau (CVB) to develop a plan to address this increase
 in safety concerns.
 - In particular, an incident in the East Village neighborhood has triggered a strong reaction from the aforementioned.
 - Business owners throughout Downtown have expressed frustration with employment due to the perceived safety issues in the community.
 - Cadavona suggested the idea of partnering with large organizations who already utilize their own private security to ramp up safety presence in certain areas.
 - The City has received additional funding dedicated to providing beds for those experiencing homelessness in/around Billie Jean King Library and Lincoln Park.
 - Cadavona, Martinez, and Metoyer discussed storefront vandalism and window break-ins. Cadavona
 noted the financial burden this imposes on small business while the City takes a while to process the
 request for funding through the Visual Improvement Program (VIP) Grant. Metoyer suggested that
 DLBA can potentially be a facilitator in getting this funding to business owners faster with the help
 of the City.
 - The Committee considered the points made when discussing how to enhance safety services
 throughout the Downtown districts. One option is to utilize the current contractor, Block by Block,
 and increase shifts to improve upon the existing system and presence of Ambassadors. The second
 option is to hire a new security company with expanded services and methodologies in handling
 safety issues.
 - The committee chose to temporarily test out the new security company with increased safety training as a pilot program, then will reassess to understand the benefit vs. cost.

<u>ACTION:</u> Approve funding for increased safety services through a private security company as a pilot program in the Downtown.

MOTION: 1st: Love; 2nd: Gold.

VOTE: None opposed. Cadavona and Carter not present for vote. Motion passes.
