3. Public Safety Committee Overview

- Gallardo provided an overview on how the committee addresses public safety misperceptions, shares information among agencies, and forwards grievances to city offices.
- Safety walks are used to identify issues in the Downtown. Individuals on these walks have worked on projects like resource guides, fixing streetlights, and influencing library and police improvements.
- There is an ongoing focus on measuring public safety perceptions in Long Beach.
- New members of the committee include: Mark Jensen and James Turner
- 4. Update on 2023-2024 Committee Projects
 - Fresh Start
 - The Fresh Start Program collects hygiene items and supplies through donations from local businesses to support the unhoused population, with items distributed to organizations like the Long Beach Rescue Mission, US Vets, and Mental Health America.
 - Safety Walk
 - The committee discussed the safety walk audits and the need for a long-term schedule for these audits, and the potential for organizing ride-alongs with the police.
 - Resources Guide
 - The committee discussed how the resource guide aims to provide information to business owners and property managers.
