Long Beach Police Department (LBPD)

Wally Hebeish - Chief of Police

- Chief Hebeish spoke about public safety concerns in the South Division, paying particular attention to problems in Downtown Long Beach (DTLB).
- He addressed the significant increase in violent crime in 2024, as well as property crime, homelessness issues, and staffing challenges.
- Chief Hebeish stressed the importance of community engagement when working with law enforcement to help improve overall public safety.
