 - DLBA's Executive Committee asked for the Finance Committee to consider a discount for certain businesses that are part of the Downtown Parking & Business Improvement Area (DPBIA).
 - The Committee considered discounts for the first year a new business comes to Downtown Long Beach (DTLB), or for businesses that have spent 10+ years within the district.
 - The Committee wants to better understand how this would compromise DLBA's revenue before making a recommendation.
