Project #1: Fresh Start Donation Program (Lead: Smith)

Milestones:

January - March

- 1) Determine length of donation campaign (Launch and end date)

- 3) Determine if committee desires to focus on one or more organizations to donate
- 4) Determine businesses and neighborhood associations to focus on
- 5) Determine how to acknowledge businesses and neighborhood associations who allow donation boxes
