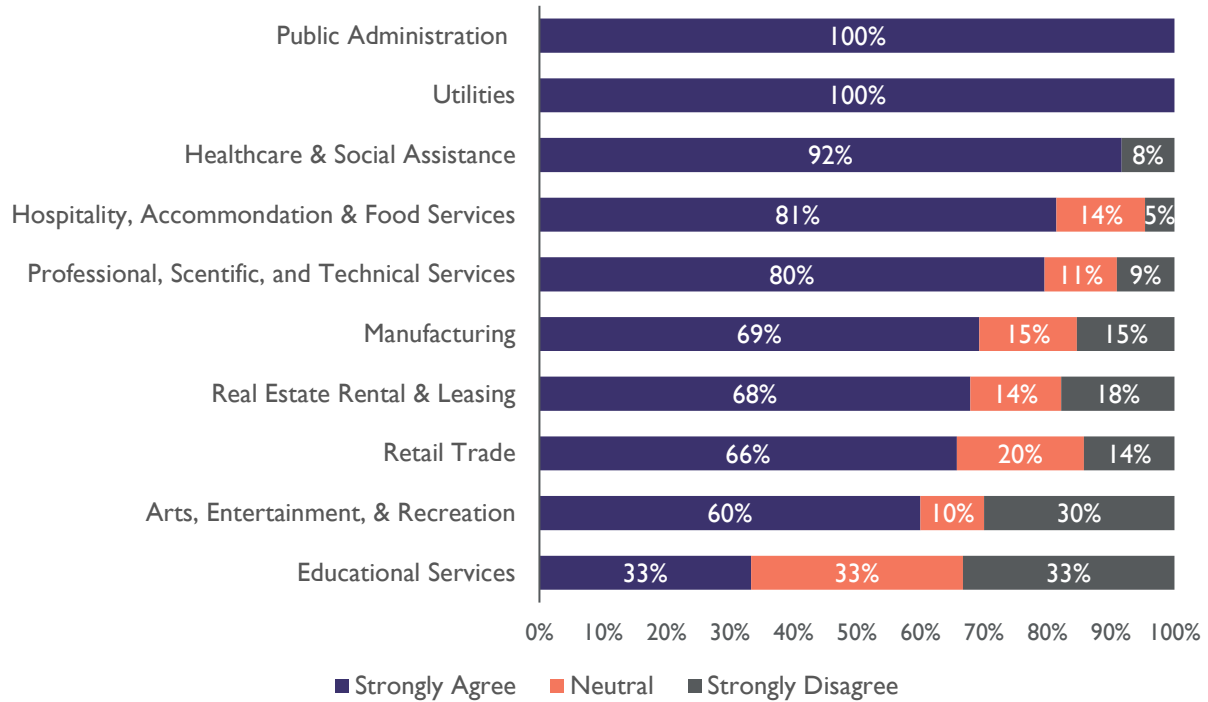

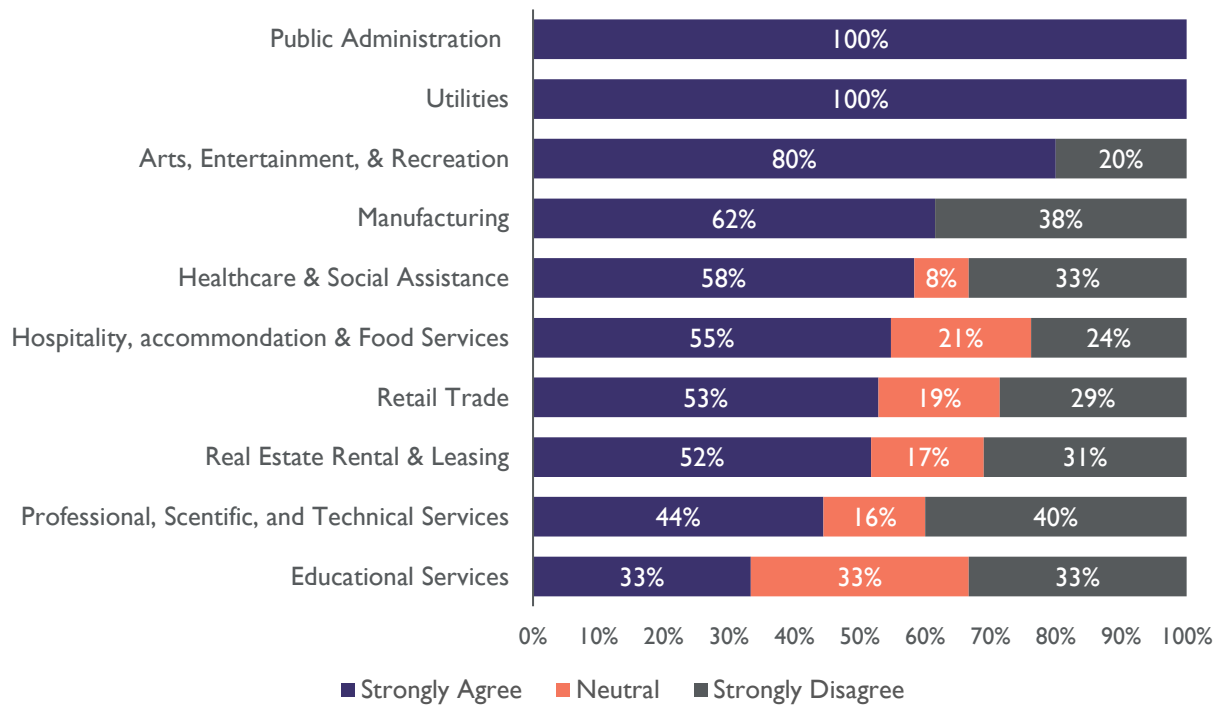

Q1 & Q14_I (Industry and Confidence in LB Economy)



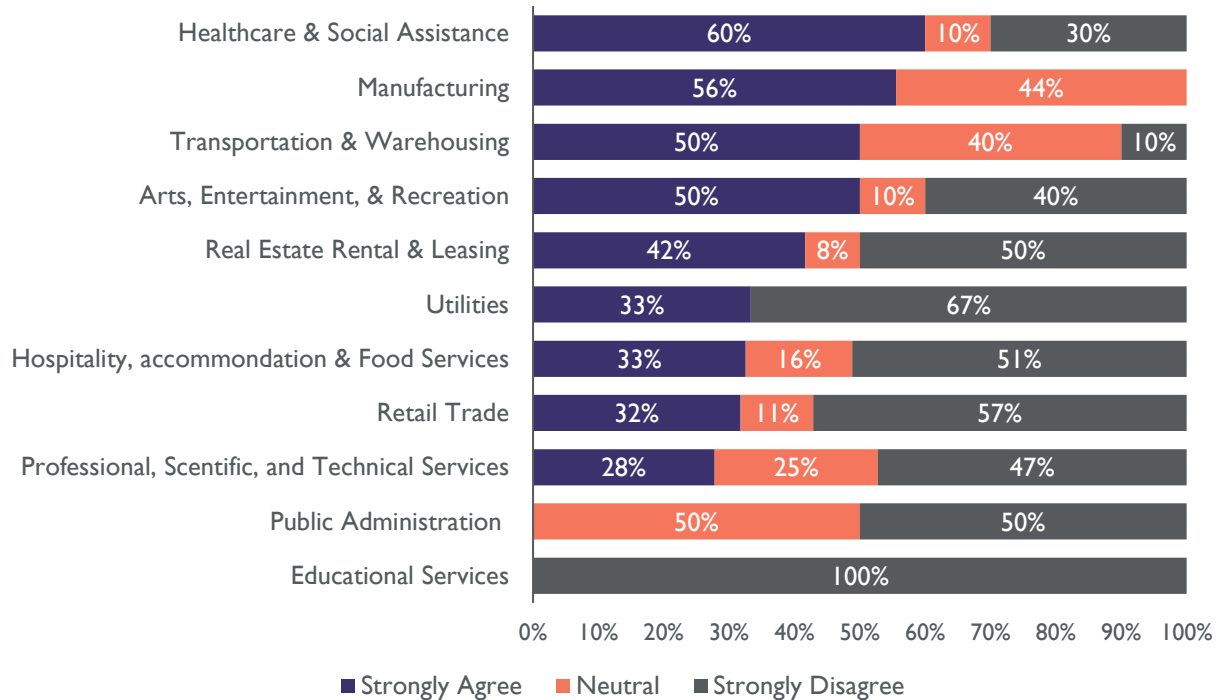
Q1 & Q12_3 (Industry and Availability of Desire Office Space)



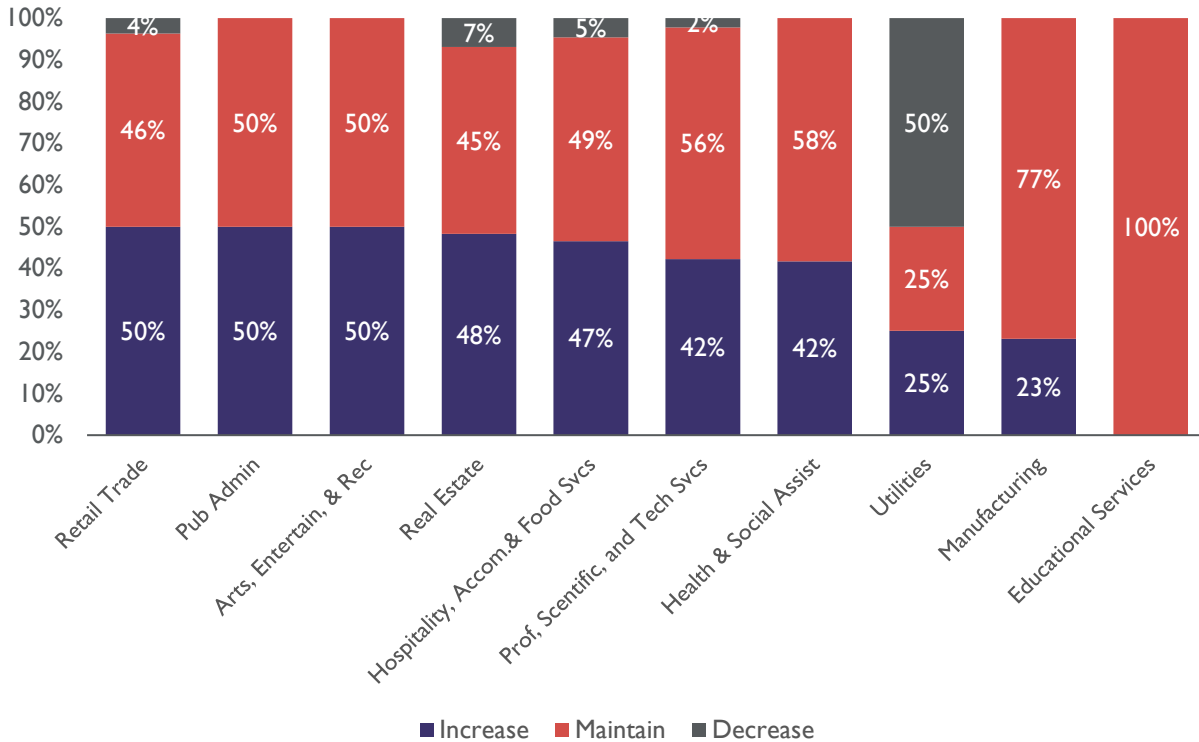
Q1 & Q12_8 (Industry and Recruit Skilled Workforce in LB Market)



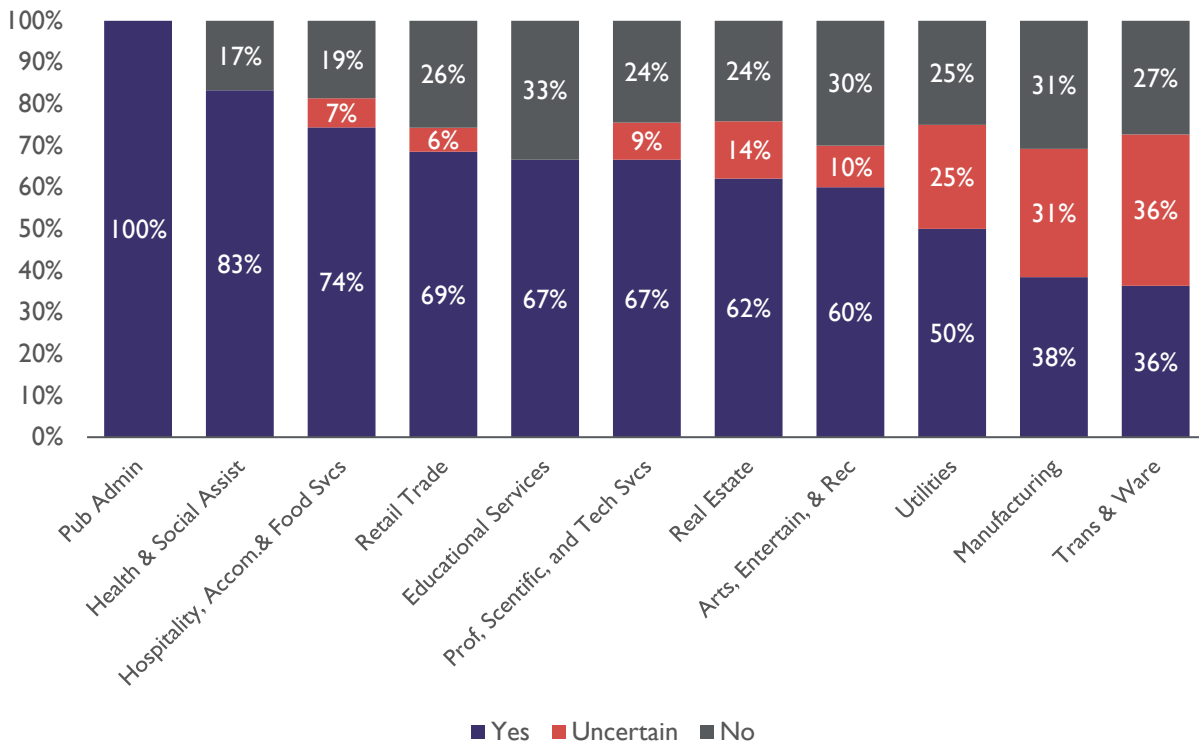
Q1 & Q12_9 (Industry and Employees that want to live in DTLB can Find Affordable Options)

- dlba is very helpful ,dlba system is very hard to navigate
- Being able to help homeless, and clean up trashy sidewalks around the business area.
- Businesswise, no. I mean it is what it is right? The only thing I would say is that it is a rough corner. You know with the homeless people and stuff like that. That's about it.
- Cheaper prices for property.
- Crime is a big problem. I have people breaking into our mailboxes daily. The LBPD says it's a postal service issue, and not an LBPD issue. I actually have a tenant who has to move out because of the people taking the mail, and he had some identity theft happen to him, and nobody will do anything about it. There was one guy who was actually using a postmaster key to open the boxes, and then other people use things like butter knives and different things. There are even you tube videos on how to break into the mailboxes. I've called to ask for assistance from the long beach authority and people came out, but no one ever came to follow up. I pay a lot of money to the Downtown Long Beach assessment office, I've called them to ask for assistance, and they never respond. The problem is they need to solve the issues of crime. The mailbox is now unsecure because it's been broken into so many times. The city is unlivable because of the hoodlums that walk around. There is still some tagging, people using my alley as a bathroom, and I feel bad because my tenants have to walk past that. We have to move people out of the alley ourselves because the city says that it is not their problem. The quality of life is poor because of the people who walk around looking for an opportunity.
- Definitely, we need more promotion. More public events to promote our business would be nice. We've been in business 7 years, and not enough people know we are even located here.
- Dlba provide great services on pine st all the way up to 5th street when big businesses are, but stops at 5th streets. Homeless people sleep right at my door, and streets are dirty in area, but dlba does nothing to correct that.
- DLBA should be more proactive in cleaning the street in our area of downtown. When I call them, they come in and spend half a day cleaning up, but they do not do such a good work.
- Doing business here is really good. It's a mix of different people that brings in a lot of people to our business. It's good for business out here.
- downtown long beach alliance does not support businesses on pine
- Downtown Long Beach needs to know how to be more proactive about the homeless situation because my clients consistently say they don't feel safe coming to downtown Long Beach and I have lost customers. I do like the city guides; they respond promptly and they are good. It's the overall safety of downtown that is a problem. I like that they are trying to make improvements with nicer apartments and such but if they don't solve the homeless issue it may not help because no one wants to look across the street at a thousand homeless people. There are times I want to move my business because the

homeless problem is something I can't control. I am fortunate that I have another business location and some customers will go to my other location rather than come downtown where they refuse to come. The homeless situation is driving both customers and business away.

- I am confident that the city of Long Beach will do a good job. They have already started to build building and upgrade the port in the city.
- I am happy working in downtown.
- I am new to the area so I enjoy my surroundings and enjoy working down here. I am concerned about my safety and it is hard to find parking and valet parking is not very welcoming. When I leave at 2 or 3 am I don't see any security and it is sad. I was driving to work and there were a couple of guys having a knife fight in broad daylight at 3pm. I had to escort someone out who was homeless and who had a drug issue and grabbed food off the serving table, and then went outside and tried to do drugs in front of the restaurant. When I left at 3am she was across the street yelling and threatening me. Security does not come when called. Homeless are camping behind the restaurant and using the area as a restroom.
- I am very concerned about the homeless situation. They come in and out of the office and it puts a damper on the professional environment.

- I don't really have any comments. My business is not a retail where people can come into my office. It's not traditional where I get clients from the local area.
- I enjoy working in long beach
- I guess I would have to say that the big corporations vs. small business, don't get the same support from the city. For example, parking. They gave the entire second floor to an architecture firm so now my students and myself have to park at the top of the parking structure and it's not convenient. There is a Starbucks on every corner and they are allowing the homeless population to hang out outside their business. 7-11 allows them to hang out too, and no one does anything about it. It seems like with the big corporations, they don't care. I don't feel any support from the DLBA at all. I mean they're all nice people individually, but the corporation itself is bad. I've asked for assistance from the city to help with the problem. I've had a guy expose himself to me in my store, I've had people scream at and threaten my students. They pee in front of my studio, do drugs and alcohol on the Starbucks patio and they let people do it because it is left unmonitored. I've told numerous people, and they all just pass it off on each other. It's a big deal and it hurts my business. I've had customers say they're not coming back because they've gotten yelled at, they've thrown food at my door. I pay \$900 a month to the association, and I still have to clean up myself. When they do come to clean, they used to come at 6am, but now, they come during business hours. I've had students slip on the side walk outside my studio, they bring their loud trucks outside and since its business hours, they don't bother to clean up in front of the patio of the Starbucks since there are usually customers outside. I've called the DLBA to complain about it, but they tell me that they can come at any time they want. I call and email, and I've given up because they just ignore me now. It's a big safety issue because all businesses are open at this time.
- I guess it's kind of related to the business. But knowing there are a lot of other Starbucks' and knowing my peers, and other food businesses, there is always a problem with water. We don't give out free water and people are always asking for cups of water. Maybe they can put more water fountains in the downtown are so they won't have these problems. It's not that we don't want to give people water, but it's a strict business policy to no give it out because it causes a lot of problems. Maybe they can have water fountains and like public restrooms too on the beach or something.
- I have employees that wanted to move downtown but did not because it was not as good for raising children as the east side of Long Beach. Although cost was a factor, it was the school environment that was not as good downtown. Downtown is not considered to be a great place to raise kids. As kids become school age people take a look at living downtown. No college educated parents are trying to get their kids into the schools down here. The schools are not set up for people in the lower upper class. When kids get to a school age people decide to move to Orange County or South Bay or Redondo Beach rather than have kids in a school in the urban environment in Long Beach.

There are a lot of residents in the city of Long Beach, but not enough businesses, so the majority of the residents commute to work. A little more industry would also create a little more traffic. Downtown Long Beach is a working class neighborhood. More industry would help create more diversity and could provide more traffic for the businesses. A lack of parking is a barrier to growing our business. There are many people who come from out of town and try to find parking, and not being able to often drive people away. Also, better signage for parking. Often times when people are coming from out of town, people who are not local are not aware of alternate places to park near downtown. Better signage would give out of town guest other options for parking locations.
- I think it would be great if they would do more for the homeless people. They are not well mentally. If they could keep it cleaner, especially in the allies. There are a lot of pot holes in the allies as well. They need to work on picking up the trash because some time it takes a long time.
- I think that the Downtown Long Beach Alliance is a penalty on business people that no one really likes. No one wants to be a member and there are a bunch of lawyers who don't want to pay the fee for it. The city is so concerned about building apartments and things around here, that they are not business friendly. They get you in and then they

forget about you. I went from a large law firm to a solo practice and you just don't get that warm, fuzzy, business feeling like you do in Torrance. I think Torrance is more business friendly. Long Beach politicians have no caring for business. I am not happy.

- I think the business fees are excessive for the downtown LB area. I think the small businesses providing services in the downtown area could benefit from programs such as one that employs people for write offs. All the current services seem to focus on retail and real estate, but not the other small businesses.
- I want to make sure we are put on the map with special events so people have knowledge of and access to our business. With New Year's Eve there was confusion with locations.
- I wish you guys could get local internet that we could all pay through taxes. That's about it.
- I would like the sidewalk in front of our office repaired, it is broken and people have fallen. It has been temporarily repaired several times but it does not stay fixed. The Weston across the street had the same problem but it was fixed. But on our side no one seems to care. There was a lady here from out of town for the dog show who was walking her dogs and she fell and skinned her knees. I offered paramedics and she said no and I offered her ice. Our sidewalks are important to be nice for people to walk on. The district says we are not scheduled for it to be repaired. Do they want a lawsuit? Because that is what will happen next. I am just looking out for the city. Why have a lawsuit for the city? The police department is great and so is the fire department. The police and fire are prompt courteous and efficient. Our neighbor had a flood and the water was running down the gutter into the street, and we called the fire department and they checked it and it was a water leak problem and they contacted the owner and told them to fix it. Also I can remember when it wasn't safe for a lady to walk on ocean blvd when the Navy was in with all the bars, but now it is safe.

- Thanks so much for doing this survey. The questions I answered 'don't know' to shows it would be great if the DLBA would let us know about programs that are available to us. Also step away from all events that close down shoreline drive, such as the grand prix and tour of California. It makes it difficult for our customers in LB and outside the area to reach us. It makes it difficult for us to be first on the list to visit when the last time they were here the businesses were not accessible.
- The area needs to be cleaner and safe. I have people jumping over the fence I need more police. They steal a bike from my customer I have it on camera. This area is not safe. I have stuff inside the fence and they still take it.
- The big problem we have is the homeless sleeping on or about our property and the trash and debris which is on private property which we have to clean up vs public property which the city has to clean up. We have called the homeless outreach center and they

have been pretty awesome about coming out and asking them to move so we don't have to personally.

- The biggest concern for retailers is the pan handlers and homelessness around the area.
- The California Tour of California is the worst thing they can do. It blocks all the roads and makes it difficult to get to any of the restaurants or our establishment. They do it on Mother's Day weekend and that's one of the busiest weekends of the year for us.
- The city should focus more on small businesses, rather than the large corporation doing business in long beach. The city made it very difficult for us to open our business due to very high rent.
- The comment that I would like to make is that the cost of a business license is insanely insanely high. They had a special assessment thing or whatever, and I never voted on it. But, now I pay \$500 a month to keep my license, and that makes it very hard for small business owners to pay such large costs. Especially when all around southern California, people are able to get business licenses for around \$150 or less. Another thing is the homeless issue. I don't know what they can do about it, but it is an issue.
- THE CONSISTENT ISSUE WITH HOMELESS
- The direction that the Long beach business community is going is great. I have noticed how much effort has been put into Long Beach so everything is going in a great direction. It is becoming an international city.
- The homeless people keep dropping trash outside of our establishment. The trash can area has a gate on it, and broke the gate and stole the lock. They set the whole trash can area on fire. They stole our recycle bin once or twice. We had three and now we only have one.
- The homeless you can see sleeping on the streets. Other than that everything is really good.
- The main concern we have is there is an alleyway near us and we get homeless near us that we have to call the police on at least once a week. That is a big issue here.
- The main thing we've noticed is that the homeless population has been kind of, well, they've disbursed them from the library where they had a place to be, and now they're kind of just all over the place. It seems to have increased over the last year as far as our neighborhood. One thing we've noticed living and working or having a shop here, is it's not just the homeless populations fault. It's just too bad they've moved them out from having a place to having no place. I mean I'm trying to be compassionate, I'm not passing judgement.
- The only thing I believe is a problem is the homeless. They are aggressive. They wander into our building even though we are five steps up. They need somewhere to go. They sit on our stairs, they use our restrooms and even though we continually ask them not to, they get aggressive, mean and scary. It's a constant battle! Obviously there is some mental illness. I work really hard, and I get asked for money every time I enter or leave my place of work. It is very frustrating.

- The only thing I would like to see is more events in the rest of downtown long beach. Most events are done towards the waterfront and I would like to see more events towards our side of Pine Street.
- The only thing we encounter here is the issues with the homeless population. They don't have places to live so they encroach on public spaces near our establishment.
- The permitting process took a long time, about 3 months. I have been used as a poster child for how hard it was to get a permit. The city as a whole does a great job. The permitting process hopefully has been made easier. Keep building.
- The vandalism situation and parking. Downtown is dying. For several reasons, the violence and destruction of property. There have been random acts of violence, and destruction of property. I had to pay \$2000 in insurance deductible last year, because someone bashed in my door (business). That is why I am leaving. It's getting worse. It's not customer friendly. I believe our street was targeted because when my customers pull up to drop off their pet, even if it took 10 seconds, the parking monitors were harsh. We lost a lot of customers. They were tired of getting parking tickets. Also, the homelessness situation and there is litter everywhere. My customers have stated in the past that they did not feel safe walking up Elm Street. I saw the area devolve. I had to either move or close my business. On the day I met with my landlord, to tell her I was going to move, the large pane glass window was smashed in. I still haven't received a bill from the city after they boarded it up. The permit process is extremely time consuming, but everyone at city hall was nice and polite. **THERE IS NO SENSE OF URGENCY WITH THE CITY TO HELP OUT SMALL BUSINESSES!!!!** It feels like you are on your own. The commercial rent is too high. You can't make a small business work with the overhead. I'm responsible for my employees, and every hoop we have to jump through they are losing a day's pay. I work 80 hours a week just to pay my land lady. My business shouldn't be just to create jobs for other people. That's not right, and that we have to pay to be a part of the association, meaning the DBLA, it just doesn't make any sense. It doesn't foster any friendly parking, nor any incentives for businesses at all. It's dirty and unsafe. The people from the 4th floor of City Hall are wonderful. Lori from licensing is wonderful. I love my business and I want to work in downtown Long Beach. We are up against all these obstacles of working downtown. We have managed to survive but I'm moving to 7th and cherry to thrive. We are getting out of downtown!
- There has been more noise from more businesses by throwing parties without a permit and blasting music from businesses. Now the residents and the businesses are now at odds with each other. When they had that music taste event, it created a huge mess with the residents. When the DLBA gives a packet it could say to keep the music down and mention if a business wants to have an event they need to be permitted and check with special events. The new businesses do not obey that and no one enforces it. Also there is more dog waste around which affects the food business. The DLBA put the dog bags out but there is not enough garbage cans to put the waste in. People are not picking up after their dogs. Bikes are on the sidewalk and they are not permitted on the sidewalks of business districts and there is not enough enforcement. They have bike lanes but they

are not being used so they effect the customers on the sidewalk walking. We do appreciate the DLBA, especially the clean team.

- There is a lot of new building which suggest progress and energy. I am happy with the support and progress that seems to be made.
- There should be a different protocol for signs outside. Everyone on pine does it, but if you get caught, they make you take it down. There should be like a licensing department or something for that.
- There was a fight next door. Everyone called 911, and it took forever to get a cop out here. It took an hour for them to come. They should have more people on bikes to keep this place safe. They also should clean more often its dirty.
- There's lots of fees and permits and stuff. It's not really helping the business because it's so much money and we're a small business. There are too many permits.
- They are doing a good job. If they could more proactively deal with homeless people that cross the line, as far as loitering or crime.
- They need to clean up the downtown area of the homeless people. It's gotten much worse in the last couple of years. They need to provide some kind of housing or services to help the homeless people, it's really bad.
- They should do something about the homeless people in long beach. There are a lot of indigent people with tents. They should do something for them. With the rain there is nothing to do about them out in the cold. It also does not look great for the city. Who wants to come to a city with homeless people everywhere? Having tents outside does not look good for the city. A transient look is not a good look for the city. It's a security issue too because the homeless have nothing to lose so the crime rate would go down if we could do something. For them it is better to go to jail then to be out in the cold which then causes an increase in crime because of their need. They would have three meals a day, take a shower, watch TV, etc.
- they should stop closing shore line dr. except for long beach grand prix
- They're good with me.
- This area of 9th and Elm, does not appear to be of importance to the City. The public service department, trees, streets, sidewalks, street sweepers, don't maintain the area as they should. This is very bad. There is trash everywhere, every day. And, this is not conducive to running an event center.
- too much crime and homeless people for visitors of city
- Too much taxes. Too much red tape. Fire department is unreasonable. Health inspection is unreasonable. We already get inspected through our corporate. It interferes with our business too much.
- Too often we see cops a lot with machine guns because of crimes and it scares the customers and we get a lot of drug addicts coming. They need to put more big businesses and an anchor stores. People would come down here to go to a large store and then make their way to our little stores. But there needs to be something to draw them down here. They need to make the place look better, more presentable and more affordable because people are moving away and not shopping here anymore.

- want more foot traction
- We are happy with the landscape here in long beach. The growth in downtown and the ability to find quality candidates is positive. The new buildings going up is good energy for the downtown economy.
- We are probably moving to a different Long Beach location.
- We enjoy working in the Long Beach office and we don't have much to complain about. Long Beach is going through improvements and the atmosphere as a working place will be much improved in the future and many people will come to open their business. Also the area has great access to the Long Beach airport. We are trying to set up an appointment with the Mayor to explain what we do and hopefully in the near future I will have an opportunity to speak with the mayor.
- We have clients in and we are at Pine and Broadway. While I am very sad about the situation of the homeless, there are many instances where our employees and clients are approached in an unfriendly way and it's a sad situation. While my heart goes out to the homeless, I am concerned about the safety of my clients and employees. It can get rough at times. I know there used to be a lot more police presence in the area many years ago and that has since gone away.
- We love it. So far it has been good. It could have more potential, but it needs a little more support from everyone including the city.
- We need a wide range of homeless services to address the homeless issue. They need a comprehensive approach. There is also a problem with the disabled people. They need to come up with a way to help them. My office is located off of First Street and it is a big issue for us.
- We would like very much to be involved in any extra curriculum activities happening in our area of downtown, and we think that there should be more of them.
- What I have concern about is that I pay for my business license, I pay for my health inspections and any other primary fees. People are allowed to come to the city, right in front of my store and pitch a tent to sale fruit and other things. I've reported it to the city and the health department several times, but it seems to be of no concern to anyone I've reported it to. I just don't think that business is being properly done in that aspect.
- When I started my business it would be helpful to have gotten more information on sales tax vs use tax, vs bus. licenses because I got penalized for doing it wrong.
- When you apply for business licensing, they should have more information. The website doesn't provide the information clearly. You have to do a lot of searching and finding for the information. I got a surprise when I went to the business licensing office about opening my business in downtown, information that was not stated online. That should be improved.
- Within the last year there has been a lot more homeless people around then there use to be and they have obvious mental health issues and drug addictions. They bother my employees by throwing rocks at them. It is really bad as you get closer to the beach.
- Working downtown provides a good climate and we like it.

- You know what, the one thing I would like to say is that I'm concerned about the homeless population. There are so many of them within walking distance and as soon as we leave our office, they're everywhere. The need to provide them with more resources to help them get on their feet and off the streets. It's a safety issue as well.
