Downtown Shoreline Plan (PD6)

Alan Pullman, Studio One Eleven

- Pullman provided an overview of the PD6 planning documents which covers the Shoreline Village/waterfront area of Downtown and what it will look like in the future.
- The goal of this project is to create a vibrant and inclusive waterfront with connectivity, sustainability, and environmental viability.

 - Pierzina updated the Board on the status of the Board elections. After many interviews, the Governance Committee is recommending two slates of candidates: One for the Property Based Improvement District (PBID) and one for the Downtown Parking & Business Improvement Area (DPBIA).
 - The entire slate of candidates for the PBID is returning, while the full slate for the DPBIA is new. The new members being recommended are made up of business owners throughout the Downtown, many of which are already active committee members.

 - A. Community Forums Review
 - This forum was an opportunity for stakeholders to provide feedback on how some flexible programming funds should be sent.
 - Attendees recommended more events such as movie nights and street closure events. Of the
 events that already take place, the most valued were food & beverage (such as Taste of
 Downtown) and cultural events (such as Dia de los Muertos). These are important for
 supporting small businesses, attracting visitors, and providing opportunities for neighbors to
 connect.
 - Community forum attendees also supported more tree planting and improved wayfinding signage.
 - B. Homeless Outreach Update Veronica Giron, Block by Block
 - This item was not discussed and will be moved to the next Board meeting.
 - C. Misc. Updates

- Metoyer made the Board aware of several break ins in the East Village earlier this month. There were approximately 10 businesses that fell victim to this incident.
- The Downtown Long Beach Alliance is working with the Long Beach Police Department, Councilwoman Zendejas's office, and Mayor Richardson's office to address this.
- Metoyer also updated the Board on upcoming events such as Taste of Downtown Pine and Art Walk.
