- 4. FINANCE REPORT: Jeremy Ancalade, Vice President of Finance & Administration
  - a. Year-to-Date DRAFT Financial Report through May 2023
    - Revenue continues to be higher than budgeted while expenses are lower.
    - The Operations Department's expenses are slightly higher than budgeted. This is due to increased Clean & Safe services throughout Downtown.
    - DLBA received \$80,000 from the Knight Foundation. These funds are designated towards activating Lincoln Park.
- 5. STAFF REPORT: Jeremy Ancalade, Vice President of Finance & Administration
  - a. FY23-24 Draft Budget Review
    - DLBA's Executive Committee has reviewed the draft budget. It will
      do so one more time before it goes to the full Board of Directors
      for final approval in August.
    - The proposed budget reflects the Board-approve district increase of 4.5% on both the Downtown Parking & Business Improvement Area (DPBIA) and the Property-Based Improvement Area (PBID)
  - b. Long Beach Recovery Act Grant Update
  - c. Misc.
    - Ancalade made the Committee aware of a check fraud incident. The matter is currently being resolved by Farmers & Merchants bank, and the DLBA staff has implemented changes to prevent this from happening again.
