- TIME CERTAIN 8:15 AM Update from City of Long Beach Development Services Christopher Koontz, Director of Development Services
  - Koontz provided a brief overview of the City's Development Services Department, explaining that its general focus is on what can be built where, and how it can be done safely.
  - Pierzina and Koontz discussed the affordable housing program and the first-time homebuyer program.
  - Koontz added that Development Services is spending more time in the City and Downtown to see what is going on and where attention is needed.
  - Burks and Koontz discussed the shift back to preservation work in regard to cultural heritage and history.
  - Hosseinzadeh and Koontz discussed some of the changes being made to the new Downtown Plan. Walkability and retail are important, but ultimately flexibility is key for Downtown Long Beach.

#### 6. PRESIDENT & CEO REPORT – Austin Metoyer

- Lynn Ward, Chief of Staff for Councilwoman Zendejas, provided updates for Council District 1. Currently there are ongoing projects with Public Works, Development Services, and the Long Beach Police Department.
- Ward discussed some of the recent burglaries in the First Council District, particularly those in the East Village neighborhood. To help address this there will be increased police bicyclist presence as well as a mobile camera utilized by the Police Department.
- A. CPI & District Rate Adjustment
  - Metoyer reminded the Board of their responsibility to review and approve an annual district rate assessment adjustment for both the Property-Based Improvement District (PBID) and Downtown Parking & Business Improvement Are (DPBIA). DLBA uses the annual Consumer Price Index (CPI) to help determine what the increase will be.
- B. Assembly Bill 2449 (AB 2449)
  - Mader presented the new information on Assembly Bill 2449 which outlines requirements for inperson and virtual attendance at public meetings.
  - Over the last three years, the state of California has been operating under a State of Emergency as declared by Governor Newsom. With many of the difficulties caused by the COVID-19 pandemic in the past, public meetings no longer need to be held virtually solely for safety concerns.
  - As of March I, 2023, all DLBA Board and committee meetings will return to 100% in person.
  - Because of this return to in-person meetings, a survey was sent to the entire Board to make sure it is meeting at the optimal time for as many people as possible. The new official meeting time will be announced as soon as all responses are received.
- C. DLBA Office Relocation Update
  - Metoyer review three different options for the relocation of DLBA's offices. This move will accommodate a growth in staffing for both DLBA and Block by Block, centralizing vehicle parking, and maximizing storage needs for both teams. DLBA will remain accessible to the community and Clean and Safe will maintain street level access.
