1. Call to Order, Welcome and Self-Introductions- Johanna Cunningham, Chair
Meeting called to order at 4:06 pm.
2. **Action: Approve minutes from [March 27, 2018 Meeting](#). 1st: Calloway. 2nd: Harding. None opposed, no abstentions. Motion carries.**
3. Public Safety Partners Update (Cunningham)
 - a. LBPd South Division
 - There was one serious report of suspicious activity during the Grand Prix that caused some delays during the event.
 - LBPd is preparing for Pride, the next big event in the downtown area.
 - Police continue to patrol the blue line bus service and have seen a decrease in crime along this route.
 - b. Long Beach City Prosecutor
 - Fewer public defenders are wanting to plea bargain their quality of life criminal cases, therefore there are more cases have been going to trial in the last several months.
 - Fresh Start Workshop is being held on April 25th. The program helps individuals with minor warrants or convictions that may have difficulties getting housing and/or work by clearing their records. Each time these events are held, they have more participation.
 - c. Department of Health and Human Services
Continue to work with DLBA Homeless Outreach and connecting individuals to services.
4. Working Groups' Lead Reports (Cunningham)
 - a. WG1: DLBA Docent Program (Welch)
 - Will be working with DLBA Steve Be Cotte on SOP for Docent Training Manual using Block by Block SOP for Safety Ambassadors
 - A question was asked about how to get the word out to potential docents. First outreach will be to DLBA Board/committee members to recruit volunteers.
 - b. WG2: Public Education/Enforcement for eScooters/Bikes on sidewalks (Calloway)
 - The extended pilot program is ending, and a permanent program will go to City Council for approval in mid-May. There are several

operational questions that will need to be addressed. There is an expected 400% increase in the number of scooters. If approved, there will be a lengthy (three months) application process, as there are 17 scooter vendors applying.

- Because of the timing, the safety enforcement part of the Working Group's goal will be delayed. Instead they will shift their focus to bicycles on sidewalks.
 - The City is working on improvements to the app so when a user initiates a rental, they are asked to acknowledge four separate safety rules. They will also be more safety reminders posted at pick-up/drop-off locations. More drop-zones will be around the city.
 - Officer Kris Klein reported that LBPD and Public Works collaborated on an scooter public safety video and may be able to share with DLBA to help educate users.
 - Michelle Mowery is looking at the mobility data standards that LA and Santa Monica have adopted. This will allow the city to gather data about users and help provide more specific/relevant information to riders.
 - 70% of users are unaware that it is illegal to ride on sidewalks
 - If DLBA develops educational collateral, PD can help distribute. Ideally, we would create one educational document that addresses enforcement from both the PD and Public points of view.
 - May is Bike Safety month so there is an opportunity to offer education. DLBA will work on some collateral to hand out at city bike events for the month.
- c. WG3: Public Education/Promotion of GoLongBeach app (Poe)
- Want to get the word out to the public to get the app now before the changes occur. 6-9 months until new app will be available and will have to put out a whole new public campaign for new app because the city does not have ownership of the current app and its list of users.
 - Want to educate the public on what resources are available on the app
 - Suggestion: Hold a photography contest- where the work could be published on the app. It would help get the word out about the app. Contestants would have to download the app. Offer prizes.
 - Suggestion: Have the docents promote the app
 - Suggestion: Add a category for reporting homelessness/support from services
 - Want to suggest a new name for the app that more accurately reflects what the app is used for.
 - Coward will find out how many users have downloaded the current app.
