



## DTLB UNFILTERED

NO PURCHASE NECESSARY TO ENTER. VOID WHERE PROHIBITED BY LAW.

### 1. Who Can Enter:

Any legal resident of the U.S. over the age of 18-years-old is eligible to participate in DTLB UNFILTERED. Employees, officers, principles, directors or agents of Downtown Long Beach Alliance (“DLBA”), Arts Council for Long Beach, and their respective subsidiaries or affiliates, and members of their households or immediate families, are not eligible to participate.

### 2. How to Enter:

Each entrant must register and complete the online entry form at [www.DTLBunfiltered.com](http://www.DTLBunfiltered.com). No written or mailed entries will be accepted. The online entry form must be submitted between 12:00:00 AM PS on October 1, 2018 (“Contest Open Time”) and 11:59:00 PM PST on October 31, 2018 (“Contest Close Time”). We are not responsible for delayed or failed submissions due to website or internet access issues.

### 3. Contest Dates:

The Contest will begin at 12:00AM – October 1, 2018 and end exactly at 11:59PM – October 31, 2017. The judging will be based on number of eligible entries properly submitted, completed and received by 11:59PM – October 31, 2018.

### 4. Selection of Finalists:

Five finalists from each category will be chosen by selected judges. Each finalist will have their selected photo printed and mounted for a gallery display starting December 8, 2018. After the gallery exhibition’s conclusion, the mounted photo will be available for pick up at the DLBA office located at 100 W. Broadway, Ste 120, Long Beach, CA 90802. Note, additional exhibitions may be added to the program at DLBA and the Arts Council for Long Beach’s discretion.

### 5. Finalist Notification:

The finalists will be notified by DLBA via e-mail at the contact information provided at the time of entry. The finalists will be required to respond to the e-mail notification to acknowledge receipt of the notification. If no response is received by DLBA from the winner within four weeks after initial contact, the finalist will forfeit their final printed copy of their photo. All decisions by the DLBA about the finalists are final, binding and non-appealable. DLBA is not responsible for any incorrect or illegible address information or the non-delivery of any photo resulting there from, or for any unsuccessful efforts to notify a winner. It is the sole responsibility of the entrant to notify the DLBA by mail if the entrant changes his/her email address. To do so, send notification to: DLBA, 100 W. Broadway, Ste 120, Long Beach, CA 90802. In the event of a dispute regarding who submitted an online entry, the entry will be deemed submitted by the authorized accountholder of the e-mail



account.
